Those requirements may be different from other health regions you operate in. The Calgary area health inspection office is 403-943-2296.

#### **Approved Farmers' Market**

We are proud to be an Alberta Approved Farmers' Market and must adhere to the guidelines established by Alberta Agriculture, Food and Rural Development, and the Food Establishment Permits of Regional Health Authorities. Simply put, 80% of products must be from Alberta. Additionally, we must respect the retail businesses established at Deerfoot City.
